Editorial

We have had a difficult year behind us. The COVID-19 pandemic, the devastating earthquake in Zagreb, and the severe earthquake near Petrinja at the year's end, have had very harsh consequences for many Croatian citizens. Luckily, our Institute was not damaged in the earthquake. We guickly adapted to working from home, adhering to the recommendations of the competent ministry. We spent a significant amount of programme funding for an urgent purchase of additional computer equipment. We organized ourselves in continuous shifts of the management and professional services, and the regular attendance of researchers according to daily schedule, thus combining work from home and from the Institute's premises, while complying with all the recommended epidemiological measures. We organized our meetings online, via available platforms. This proved to be a good way of protection. Although a few employees caught the virus in their family settings, the virus did not spread among other employees, because all the infected were adhering to all the recommended measures of self-isolation and disease control. In accordance with our public function, we actively engaged in mitigating the situation and consequences of the pandemic and the earthquake in Zagreb. Also, we immediately engaged in organizing online school for primary and secondary pupils. We reported about that in the previous number of the Newsletter. We continued the work on our ongoing projects. In 2020, the Institute conducted 12 competitive international research projects, and there were a total of 38 projects. We successfully completed the submission of projects to a number of competitive international and national calls.

 We started 3 ESF projects and 1 Erasmus + project, which is a continuation of the previous Erasmus + collaboration within the *Hand in Hand* project;

- In 2020 we began the implementation of two bilateral projects with Slovenia. One is financed by the MSE, and another is a result of the first bilateral competitive call of the CSF and the Slovenian Research Agency: Quality of living in the Housing Estates of the socialist and post-socialist era: a comparative analysis between Slovenia and Croatia (HESC) Principal Investigator for Croatia is Andelina Svirčić Gotovac, PhD.
- We started 3 CSF projects: Integration and disintegration of the European Union: Dynamics of Europeanism and Euroscepticism (IDEU), CSF Installation project led by Nikola Petrović, PhD; The social resilience of Croatian society in the midst and aftermath of the COVID-19 pandemic (SOCRES), HRZZ-IP-CORONA-2020-04 Research project led by Branko Ančić, PhD, and The role of personality, motivation and socio-emotional competences in early-career teachers' occupational well-being (Teach-Well), CSF Research project led by Iris Marušić, PhD.

We signed a collaboration agreement with the Edward Bernays University College. The result of this collaboration is the joint organization of the international conference *Communication Management Forum 2021*, in March 2021 in Zagreb.

We continued our collaboration with the University of Rijeka and University of Ljubljana, and the result of this collaboration is the co-organization of the international conference titled Youth work in flux: an academic point of view on youth work training and education, in June 2021 in Rijeka, and the enrolment of the new generation of attendees in the lifelong learning programme Youth in Contemporary Society, delivered in collaboration with both Universities.

We successfully passed the process of evaluation of the Institute's implementation of the Human Resources Strategy, which was evaluated as excellent by evaluators from the European Commission. Thus, we acquired the right to continue the use of the "Human Resources Excellence in Research" logo.

In addition, our membership in international networks EERA, ESA, ISA and NEPC was continued.

Within the dissemination part of our scientific research work, we participated in 26 international and 28 national conferences held online. The total scientific production of the Institute in 2020 encompasses 2 books, and 42 scientific papers, of which 26 scientific articles and 16 scientific chapters in reviewed books of international and national publishers. All of the above is presented in more detail in the Newsletter and at our website.

The **Sociology and Space** journal has a new cover design as of this year, and is printed on recycled paper. In addition, there were plenty of papers received within the Editorial board's call for contributions to the special issue dedicated to various individual and social aspects and consequences of the pandemic and the earthquake. All this suggests that in the previous year, despite unfavourable circumstances, we were extremely active in our scientific research work, not just through the understanding and explaining of existing and occuring problems, but also in an attempt to solve them. In the end of the year, and based on the recommendation of the Institute's Scientific Council, the Institute's Managing Board (President Krešimir Nemec, academician and members Associate Prof. Anna-Maria Getoš Kalac, PhD, Vanja Pavlović from MSE, Iris Marušić, PhD and Dunja Potočnik, PhD) unanimously confirmed the appointment of Boris Jokić, PhD as the new Director of the Institute for Social Research in Zagreb. By this appointment the Institute is getting a "new momentum". The change of generations that was happening in previous years following the retirements of our longstanding researchers, resulted in the concentration of the young forces that carry new ideas and new energy, necessary for the drawing up and implementation of various projects in a complex world of extremely precarious working and living conditions, that is, the world filled with various challenges and problems, to which the social scientists need to find scientifically based answers. The completion of my mandate as Director happened at the same time as my retirement. After 35 spent at ISRZ, I am very pleased to say that I spent them in an institution that has been marked by academic openness and freedom, continuous striving towards excellence in scientific research work, continuous caring for the people, and in that sense focusing on solidarity as a central value, thus creating a great working environment. All this was proved by the recently conducted internal anonimous questionnaire survey of work contentment at the Institute, conducted among all employees. My contentment is thus greater, since the Institute stays in the hands of extremely hard-working and competent young people.

Ongoing projects in 2020 International projects

The Institute conducted a total of 12 competitive international research projects in 2020. Out of that number, three projects financed by the European Social Fund began in 2020. These are the following projects: "METER to a better climate (Network for Education, Transition, Adaptation and Development)" - Principal Investigator for ISRZ Branko Ančić, PhD; "Thematic Network "Lifelong Education Accessible to All" (TEMCO)" - Principal Investigators for ISRZ Iva Odak, PhD and Saša Puzić, PhD and "Work Fit for People" – Principal Investigator Teo Matković, PhD. In all these projects the Institute is a partner in charge of scientific research, while the coordinators are civil society organizations in charge of the coordination and gathering of partners in thematic networks formed with the aim of solving particular social issues. Thus, the "METER" project addresses the combating of energy poverty, the "TEMCO" seeks to strengthen the civil sector in reducing inequalities in education, while the "Work Fit for People" project investigates the circumstances at the labour market, with a special focus on empowering trade unions in the protection of rights and improvement of the position of fixed-term employees. Furthermore, in the previous year we successfully submitted a new three-year project, which will be financed

from the Erasmus + programme. It is the project titled "Hand in Hand: Empowering teachers across Europe to deal with social, emotional and diversity related career challenges". It will be implemented with the Network of Education Policy Centers (NEPC) and additional nine partner organizations coming from various EU countries. The project coordinator is the Educational Research Institute, Ljubljana, Slovenia. Also, it needs to be pointed out that this project is a continuation of the "Hand in Hand: Social and Emotional Skills for Tolerant and Non-discriminative Societies (A Whole School Approach)" project, which was implemented with the same partners from 2017 till 2020. Principal Investigator on both projects is Iris Marušić, PhD.

In 2020 we successfully carried out the project titled "Equal rights – Equal pay – Equal pensions" financed by the EU programme Rights, Equality and Citizenship. The Principal Investigator is Josip Šipić, MA. Furthermore, we implemented the International Social Survey Programme, which has been carried out at the Institute continuously since 2005. The ISSP Principal Investigator is Dinka Marinović Jerolimov, PhD. In addition, the implementation of five Erasmus + projects covering the area of youth and youth work studies also continued. These projects' Principal Investigators are Marko Kovačić, PhD and Nikola Baketa, PhD. All international projects that were carried out in 2020 are listed in Table 1. Interview with Assistant Prof. Branko Ančić, PhD, principal investigator of the CSF project SOCRES

At the HRZZ-IP-CORONA-2020-04 call, announced by the CSF as a response of the scientific community to the COVID-19 pandemic, the financing of the project "The social resilience of Croatian society in the midst and aftermath of the COVID-19 pandemic (SOCRES)", led by Branko Ančić, PhD, was approved. The SOCRES project is guided by the guestion of what strengthens the capacities of individuals, groups, communities and organizations, or the society in general, enabling them to positively respond to threats and negative impacts of catastrophes, such as the COVID-19 pandemic. The theoretical grounds of the project are debates on the concept of social resilience that refers to the capacities of human communities to cope with externally caused shocks to their infrastructure and to successfully recover from them. Besides the project leader and the Institute's researchers Marija Brajdić Vuković, Adrijana Šuljok and Lana Peternel the project involves 21 researchers from 10 institutes and universities from Croatia and abroad.

Below we bring you an interview with the project leader.

What is the main aim of the SOCRES project?

The COVID-19 pandemic has already resulted, and will continue to result, in ruptures, traumas, adversities, threats, tragedies and significant stress. This pandemic creates new landscapes of inequalities, draws new world maps, and new local political maps and power relations. The overall research aim of this project is to investigate how societies react to these processes, with an emphasis on the characteristics of social resilience in the Croatian society in the midst of the COVID-19 pandemic and their immediate consequences. The participants of the project research activities will be representatives of the broader public, and experts, politicians and activists.

• In the previous year we witnessed a great change in the way the broader public perceives decisions of the National Civil Protection Headquarters, from an almost heroic image during the first wave of the pandemic, over gradual losing of citizens' trust, to the completely negative attitudes resenting the Headquarters the lack of political neutrality. Could you comment on this?

Our research, which was conducted in autumn within the SOCRES project, showed that 83 % of Croats still have high trust in scientists and their ability to find a therapy or vaccine for the coronavirus. However, the trust in the Government, the National Civil Protection Headquarters and the media decreased. Strongly. According to data, when it comes to managing the coronacrisis, the Government is not trusted by 45 % of citizens, the media is not trusted by 50 %, and the Headquarters by 33 %. As many as 40 % of the interrogated citizens report lower levels of trust in the work of the Headquarters than in the beginning of the crisis in spring. Altoghether, it seems that the level of trust in the Headquarters will continue to decrease, primarily because the measures that are brought are not applied consistently and do not apply equally to everyone.

Since the beginning of the project implementation until today we see that vaccination has begun, whereby around 50 % of citizens do not want to be vaccinated, according to research. What do you think are the reasons for a relatively low response of citizens to vaccination?

Findings of social research nevertheless need to be read more carefully, and we need to be cautious and responsible. Respondents were asked whether they would take the vaccine if the vaccine was available in Croatia, and only 21 % of respondents said they would definitely not be vaccinated, according to some domestic agencies' research. In our research we extensively dealt with this group as well. We used the term «antimaskers», which does not encompass just those who might be against vaccination, but also those who relativize the outbreak of the disease, as well as those who find that corona is utilized as a means of threatening individual freedoms (reflected also in the obligation of wearing a mask). There are less than 3 % of such respondents among our pool, while there is around 14 % of those who say that «the coronavirus is like flu». The remaining 83 % nevertheless find that the pandemic is not a party. Still, here we have an interesting phenomenon. Although the real number of these «antimaskers» is relatively small, the media space that they are getting is almost the same as the one given to those who trust science. Also, the so-called antimaskers' group is much louder and somewhat more visible in the media because of their using of a sensationalist vocabulary, while the opposite side uses argumentation and facts, which are always harder to convey in such a

way that they create a stronger impact on the public. In other words, it takes more time and effort for the public to accept them. Nevertheless, the group of antimaskers is taken altogether a lot smaller in number than the group that trusts science. A text addressing this topic will soon be published in the Sociology and Space journal.

• To conclude, in what way will the SOCRES project contribute to the resilience of the Croatian society to the COVID-19 pandemic?

The term social resilience refers to the ability of a society to withstand external shocks to its social infrastructure and to successfully recover from them (Adger, 2000). The main research goal of this project is to explore the features of social resilience in Croatian society in the midst of the COVID-19 pandemic and its immediate aftermath. Social resilience is understood as a concept that encapsulates individuals, organizations and communities (or society per se) and their abilities and capacities to absorb, cope with and adjust to threats which can be social and/or environmental in nature. The project shall result in better understanding of sociocultural and institutional preconditions for adaptation to developmental restraints that are specific for 21st century. It will be of interest to policy makers, and to CSOs, especially regarding the specific measures that can be undertaken in relation to the strengthening of the social capital, crisis communication or addressing broader enivironmental and economic challenges, which contribute to the strengthening of resilience of Croatian society. Such projects are extremely important because they shed light on the social consequences of catastrophies, analysing at the same time their causes and attempting to discover the mechanisms of empowering individuals, groups, organizations or the society as a whole for better coping with the negative consequences and possible threats.

Institute's implementation of the Human Resources Strategy for Researchers evaluated as excellent

External evaluation of the implementation of the Human Resources Strategy for Researchers in the Institute was conducted in October 2020. A group of evaluators from the European Commission led by prof. Anna Maria Eleuteri carried out a series of online talks with employees of all levels regarding the implementation of the Institute's Strategy and Action Plan. Special emphasis was put on the OTM-R ("Open Transparent and Merit-based Recruitment") employment policy for researchers, employees' professional development, mentoring of junior researchers, working conditions, institutional procedures for quality assurance, etc. Institute's implementation of the Strategy was evaluated as excellent and the Institute was allowed to further use the HR Excellence in Research logo. The implementation of the external evaluation was for the Institute coordinated by Ivana Jugović, PhD, Head of the Committee for Quality Assurance in collaboration with the Institute's Director Dinka Marinović Jerolimov, PhD.



ISRZ's Internal Seminars

In 2020 the tradition of Institute's internal seminars for employees was continued, in which some of the employees present some of the topics from the scope of their expertise, while others have the opportunity to listen and discuss. The aim is to connect Institute's researchers and professional services and strengthen their capacities and knowledge. The first in the series of online seminars was held on 29 September 2020 by Marija Brajdić Vuković, PhD on the topic of qualitative approach to case study. The second was held by Filip Fila, doctoral candidate on the CSF project "Integration and disintegration of the European Union: Dynamics of Europeanism and Euroscepticism (IDEU)", led by Nikola Petrović, PhD. Filip presented comparative studies in sociology, pointing to the traps that researchers are facing when comparing various political entities. As the starting point and example he took the book 'Religious America, Secular Europe? A Theme and Variations' (Berger, Davies, Fokas, 2008). In addition, Filip has already addressed this topic in a graded essay within one of the subjects of the study International Master in Economy, State and Society: History and Society (University College London and Charles University in Prague).


Publishing

In 2020 the total scientific production of the Institute included 2 scientific books (1 authored and 1 edited) and 42 scientific articles, of which 26 scientific papers and 16 scientific chapters. Out of the total number of scientific articles, 24 papers were published in journals indexed in Web of Science and/or Scopus, and 16 chapters in reviewed books. The Institute is the publisher of the *Science and Society Edition* and the *Special Editions*, and the scientific journal *Sociology and Space*.

Journal 'Sociology and Space'

We are particularly proud that the *Sociology and Space* journal has a new visual identity, beginning with the first number in 2020 (Vol. 58, No. 1 216). The new identity was designed by prof. Ivan Doroghy, PhD from the Study of Design at the Faculty of Architecture in Zagreb. The cover now consists, besides the names of authors, of full titles of published papers. Also, the journal is published on recycled paper. In 2020 three regular yearly numbers

were published, and are available at the Institute's website and at Hrčak.


